## Recipe corner

# Cherie's butterscotch caramels

"My mom's homemade caramels are so good that I get questions about them throughout the year. Typically, she only makes them for Christmas because her screened-in porch becomes a perfect walk-in freezer for cooling them. Our family has been making this recipe for more than 55 years. In the early days, when my mom was growing up on the family farm and her papa was milking cows, they had plenty of cream to use and even enough to sell.

Store-bought caramels aren't quite the same once you've tasted these. Mom makes small baskets of them for me to hand out to the families of my piano students at Christmas to spread a little joy." —Allison Thede Everman, Office Professional

#### Ingredients

2 cups of sugar

1⅓ cups of white corn syrup

1 cup of real butter

2 cups of heavy cream, divided

1 teaspoon of vanilla

#### **Utensils**

Long-handled wooden spoon Candy thermometer

Heavy pot, such as a pressure cooker without the lid

#### Instructions

- 1. Combine sugar, syrup, butter and one cup of cream in a heavy pot.
- 2. Bring to a boil over medium heat, stirring constantly.
- 3. Boil for 30 minutes, stirring occasionally.
- 4. Add the other cup of cream gradually so mixture does not stop boiling. Add vanilla.
- Continue boiling and stirring continuously with wooden spoon until candy temperature reaches 244 degrees Fahrenheit. Alternatively, boil and stir with wooden spoon until candy forms a firm but not brittle ball in cold water when tested.
- 6. Pour into 9-by-13-inch pan lined with lightly buttered aluminum foil. Do not scrape sides of pot when pouring; just let candy drip into pan.
- 7. Cool candy.
- 8. Remove cooled candy from pan by lifting with foil. Place on cutting board.
- 9. Cut caramels into squares and wrap individually in foil, wax paper or plastic wrap.
- 10. Store wrapped caramels at room temperature, refrigerated or frozen. They keep for one to two months or longer.





## Important candymaking tips

- Always use a long-handled wooden spoon. Metal spoons get too hot to handle.
- A candy thermometer is highly recommended.
- During the boiling and stirring phase (step five), do not stop stirring.
- Pour the cooked candy into the 9-by-13-inch pan quickly, and let gravity empty the pot.
- Heed advice not to scrape the sides of the pot when pouring the cooked candy. The leftover bits stuck to the sides are hotter than the rest of the caramel.
   They will crystalize and become crunchy, ruining the caramels.
- The mixture will expand during cooking, so make sure the pot is large enough.
