- Check your bank statements regularly and report any fraudulent activity immediately.
- Only utilize ATMs associated with a bank; avoid possible "skimming" locations.
- Change your PIN every few months.
- Shred physical account statements.
- Report a lost or stolen debit card immediately and cancel the missing card.
- Avoid public wireless internet networks when making online transactions.
- Implement two factor authorization if available with strong backup security questions.

10th Anniversary of Thrivent Action Teams

It's been 10 years since Thrivent Action Teams were launched, and we're celebrating by honoring the people who bring the program to life: our clients. We're thrilled to share that Jill Schwiderski, a client in Hector, Minnesota, was one of 10 people honored for the 10th anniversary of Thrivent Action Teams.

Jill selflessly dedicates her time and resources to running a community closet that serves hundreds of families every year. Jill's original vision for St. Paul's Closet was a small closet with jackets, hats and gloves, especially for children waiting at the bus stops. Today, it takes three Sunday school rooms at St. Paul's Lutheran Church to hold the seasonal clothing and footwear, bedding and household items that help people throughout Renville County. Jill collaborates with area organizations to reach more people and share resources, and she leads Thrivent Action Teams to collect and buy new

items such as work boots, shoes, jackets, socks, towels and baby kits. She meets with families to give them a personalized shopping experience, hear their stories, and offer hope and comfort.

Over the course of 10 years of Thrivent Action Teams, clients like Jill have led 1.2 million Thrivent Action Teams, engaging 16 million volunteers and raising \$1.9 billion! In celebration of this milestone, Thrivent surprised 10 clients by making \$10,000 donations each to causes that they care most about, including St. Paul's closet.

"I was in complete shock! It is such an incredible honor. Thank you! Thank you!" said Jill. "It's a big responsibility to use these funds wisely and I will do so! I desperately need shoes for children. Backpacks are going out like crazy! It's so fun to have some new items for these families."

Grandma's chili recipe

3-4 lbs. hamburger

1 medium onion

20 oz. tomato sauce

2 cans chili beans (Bush's Brand is a favorite)

1 can diced tomatoes

1 can ROTEL Original

2 packets McCormick regular chili seasoning

½ packet McCormick hot chili seasoning

1/8 cup sugar

½ jar of Heinz chili sauce

1 tsp. oregano

½ cup salsa

2 Tbsp. + 2 tsp. chili powder



In a large pot, sauté onion while browning hamburger. Then dump all ingredients into the large pot, add two cans of water (use the chili bean cans to get all the flavor out), bring to bubble, and turn down to simmer for a couple of hours.

Serves 10-12 large bowls. Top with cheese, sour cream, jalapenos or any of your favorite chili toppings. ENJOY!
