

Average Annualized Returns

This report shows performance as of the most recent month- and quarter-end for Thrivent Variable Portfolios.

All returns greater than one year are annualized; returns for periods of less than one year are not annualized.

Thrivent Variable Portfolios are only available to the public through a variable life insurance or variable annuity product. It is expressed as an annual percentage. The yield quotation more closely reflects the current earnings of the Thrivent Money Market Portfolio than the total return quotation.
